Project Background:

Bringing IP closer to classrooms is expected to increase the creativity and innovation skills that are at the heart of economic, cultural and social wealth. In June 2018, WIPO organised the conference on "IP and Education" with the objective to gather IP Academies and share knowledge and best practices. The conclusions of the conference highlighted that teaching IP at primary school and working with Education Ministries to introduce IP in learning curricula at primary, secondary and university level is crucial. Therefore, cooperation at all levels of education is a powerful tool to create an early understanding about IP across society. Introducing IP in secondary school curricula is expected to reinforce the positive perception about how IPRs can be used to generate value and improve livelihoods in all sectors of economy. In the Caribbean, some teachers in the primary and secondary schools are teaching aspects of IP, however, teaching materials and tool kits to facilitate communication of the lessons in "Creativity and IP" with a Caribbean culture for use by teachers are not available. This gap severely dampens the teachers' capability to teach and evaluate the subject. Priority will therefore lie on making teaching material available to enable teachers to teach and evaluate lessons in "Creativity and innovation and IP".

The IP in School Project of CarIPI will build on the experience from CARIFOURM members states such as Trinidad and Tobago, and Jamaica, which are conducting relevant initiatives, and the EUIPO's ldeasPowered@school project, under which a wealth of materials is available.

Under the same assignment, the project also aspires at developing a regional strategy to provide for the introduction of the concepts of "Creativity and IP" in the primary and secondary schools across the CARIFORUM region. This again should be based on existing work already done in some CARIFORUM countries and would derive from multiple consultations with authorities in each Member State. Depending on the policy and strategy adopted, this could ultimately result in having lessons in "Creativity and IP" embedded in the existing school curricula.

Another aspect of this assignment is the hosting of workshops for select primary and secondary school teachers from Antigua and Barbuda, Jamaica and Trinidad and Tobago. These workshops will provide an introduction to intellectual property, and teaching techniques and strategies for incorporating age-appropriate intellectual property principles into the primary and secondary school curricula.
